2nd Reading

If the Board adopts a new policy regarding discipline based on our model policy, in our view, that would replace both the district's current discipline policy, 5144, as well as: 5131.1 bus conduct, 5131.7 weapons and dangerous instruments, and 5131.8 out of school misconduct.

Similarly, if the district replaces its bullying and safe school climate policy with one based on our model, that would replace the district's current bullying policy, 5131.9, as well as 5131.913 cyberbullying.

On Future Items List

Our model policy on student records (FERPA) would also replace 5125.1 student records and 5145.11 health-medical records.
