- I. CALL TO ORDER 7:03 p.m. by Chair Tim Hagen
- II. <u>PLEDGE OF ALLEGIANCE</u> Led by Chair Tim Hagen and ELPS Elementary Students There was no objection to moving the First Selectmen's report forward on the agenda as he was expected downtown for another meeting.

Board of Education Appreciation Month

Presentations by Students of East Lyme Public Schools

REPORTS– Not objection

1. First Selectmen Mark Nickerson (ex-officio report), publicly thanked Superintendent Newton for pulling back the Board of Education approved elementary school building project and discussing it fully with town officials. He stated the current Board of Education approved project would double the town's debt and was not the most ideal plan in the long range planning of the town. He also stated that the town has no plan yet for the Niantic Center School site although it is the most marketable property and provides the most reuse. He said that the town cannot carve out and sell Lillie B. Haynes and must be used for the purpose of education.

III. PUBLIC COMMENT

 Jen Murray (7 Tabernacle Avenue, Niantic) asked the town's consideration when scheduling a Board of Finance meeting on the same night as the Board of Education meeting and provided copies of town meetings and deeds related to the Lillie B. Haynes property. She questioned why the Board did not conduct a public forum and asked that they pull back and find a better plan that is least disruptive for kids and is not a "band aid" fix for Flanders School.

- Christine Naktenis (3 Champlin Hill Court, Niantic) asked how many classrooms at Lillie B. Haynes, and how students would be housed in the interim, cost of portable classrooms and why aren't the kids at Niantic Center School while construction is going on.
- 3. Mykel Bridget Czaja (6 Pleasant Drive, Niantic) stated it is unfounded to have students attend school under construction and expressed concerns regarding the effects of noise and environment on learning and academic achievement. She stated that portable classrooms are unacceptable and have a negative impact on learning. She encouraged the Board to do what's best for our children and not settle for something that is "just good enough."
- 4. Peter Naktenis (3 Champlin Hill Court, Niantic) voiced concerns about noise, security and environmental issues for kids while construction is taking place at Lillie B. Haynes and that portable classrooms are not a good environmental setting for learning. She encouraged use of Niantic Center School while construction is taking place at Lillie B. Haynes and suggested parent representatives from each school be included on a committee during planning and transitioning process.
- 5. Kim Mazzarelli (8 Darrows Ridge Road, East Lyme) spoke of equity concerns with Lillie B. Haynes and deviation from the previous Flanders School Plan and noted that Flanders School parents are interested in having a better understanding of the plan.
- 6. Tina Carrico (50 Edge Hill Road, Niantic) opposes closing any elementary school and stated the decision should go to town referendum for public vote.
- 7. Lisa Benever (12 West Lane, Niantic) commented on the favorable location of Niantic Center School and asked the Board to consider an alternate plan for students in school during renovation.
- 8. Alisha Brothers (149 Roxbury Road, Niantic) asked to have equitable distribution at all schools.
- 9. Lauren McKee (59 Black Point Road, Niantic) shared letters written by Niantic Center School in support of keeping Niantic Center School open and expressed concern regarding transition anxieties.
- 10. Carol Russell (4 Bramble Bush Drive, Niantic) supports keeping Niantic Center School open and asked if the Board if Finance has cut the school budget for next year. She stated the Niantic Center School experience should be expanded and not dismantled and the decision to close a school should not be made in a rush. She expressed concerns regarding enrollment and urged the Board to think carefully before making a decision to close Niantic Center School.
- 11. Bridgett White (1 Sunrise Avenue, Niantic) asked the Board to keep all three schools open and to prioritize what needs to be fixed.
- 12. Jayme Keefe (6 Mohawk Drive, Niantic) noted that great things are going on at all schools. She asked the Board to consider in its plan possible mandated preschool, encouraged the Board to consider other building options, asked the Board to think carefully and slowly keeping politics out of it, and to consider all stakeholders.
- 13. Heather Treptow (179 Bridebrook Road, Niantic) said that teachers, staff, students made schools great and asked the Board to put personal interests aside and make a decision as to what makes the most financial sense for town. She discouraged negativity on the part of parents, and noted that children are resilient and the project will be an exciting time for them.
- 14. Rebecca Karun (78 Arbor Crossing, Niantic) echoed Heather Treptow's remarks and encouraged the Board to move forward showing parents the positive aspects of the project to pass onto kids.

- 15. Kelly Strief (Brook Road, Niantic) encouraged the Board to table the vote on the elementary project and suggested uses for Lillie B. Haynes property (athletic fields).
- 16. Maura Ament (72 Mostowy Road, East Lyme) said the process needs to be transparent and seems rushed. She stated there is no guarantee that in 5 to 7 years the construction of a new Flanders School will pass and a band aid fix is not acceptable.
- 17. Tara Dowling (19 Pleasant Drive Extension, Niantic) stated the way the process has happened has caused anxiety and fear among the community, and people have not been informed of the revised plan. She asked the Board to consider the feedback heard tonight and to come up with a plan that is reasonable and safe.
- 18. Bonnie Dombrowski (103 Walnut Hill Road, East Lyme) stated that she moved to East Lyme nine years ago for the education for future children and is happy to pay more for taxes for education purposes, but is not getting information regarding the project.
- 19. Maia Vargas (18 Pontiac Drive, Niantic) asked the Board to meet further with the Board of Finance and Board of Selectmen to work out a feasible project and that it is only fair to parents before moving forward with a vote.
- 20. Alex Argeris (17 South Beechwood Road, Niantic) questioned long-range plan and bonding issues in town and stated the building needs to be part of that long-range plan. He cautioned the Board to take the information heard tonight and delay the vote and expressed his lack of trust in elected officials in general.
- 21. Randee Siegel (65 Old Black Point Road, Niantic) stated she respects the Board of Education and Superintendent for doing the best they can with the limitations set. She supports two schools and asked the project be brought to referendum for the community to decide.
- 22. Carla Cirone (236 Upper Pattagansett Road) East Lyme, stated she moved here because of the reputation of the schools and has no complaint about an increase of the mill rate for educational purposes, although she is not clear on the elementary project.
- 23. Jen Murray (7 Tabernacle Avenue, Niantic) stated the community is looking for clarification of the relationship between the Board of Education, Board of Selectmen, and Board of Finance and stated there is so little transparency.
- 24. Liz Banezer (12 West Lane, Niantic) stated she just received a text from Mark Nickerson stating he hopes to keep Niantic Center School open.
- 25. Kyle Douton (5 Rockwell Avenue, Niantic) attended the Board of Education Meeting of the Whole on March 24 and is disappointed that the project has taken six years. He stated he is also disappointed in the town's lack of transparency.
- 26. Marc Murray (7 Tabernacle Avenue, Niantic) could not be in attendance and submitted a letter addressed to the Board dated 03/28/16 that was read by Jaime Barr-Shelburn. The letter included questions regarding the elementary project and is included as an attachment to these minutes.

Moved to approve total conceptual cost estimate of \$82,755,855 to replace the existing Flanders School with a new facility and renovate as new Niantic Center School; advancing the project to the Board of Selectmen for their review and action as presented.

There was no objection to a modification of the agenda to discuss to VII.A.2. before taking action on this agenda item.

Superintendent Newton took the Board through an updated presentation of the elementary school building projects as dated March 28, 2016 (see item A.2.) and the Board reviewed the rationale for the revised plan.

- Based on the town's financial analysis of the Board of Education approved project and as a result of several conversations with town officials, Superintendent Newton was asked to present a revised project plan that the town could financially support.
- The proposal made by the Board of Education must be approved by the Board of Selectmen and Board of Finance before it can go to referendum. The approved project could not be supported.
- The newly proposed plan calls to renovate as new Lillie B. Haynes School, close Niantic Center School, and provide some renovations to Flanders School, but postpone the rebuilding of Flanders Elementary School in 5 to 7 years.

Flanders Refurbishment (1.5 million):

- Construct a new main entrance with updated security (visitors enter through main office).
- 2. Improve technology (Wi-Fi, computers).
- Improve quality of the environment (paint, ceiling tile replacements, refurbish bathroom tiles).
- Add/Replace light fixtures (hallways), lens covers (classrooms).
- 5. Replace classroom furniture items (tables, chairs, desks).

Referendum Proposal: Renovate as new LBH and refurbish FL with 1.5 million dollars

Failure at Referendum:

Plan B – Combine NCS into the LBH existing structure beginning 2017-2018 school year.

*Two schools with no renovations and increased costs for any future construction plans for LBH or FL.

Outstanding Considerations and Needs:

- 1. Finalize construction rendering of LBH structure
- Identify construction logistics and transitions keeping in mind, first and foremost, the safety of all children:

Options

- · Phased approach
- Portables
- Move kids between FL and NCS (Redistricting options)
- Finalize FL developed list of required improvements (1.5 million)

Elementary School Projects as of 3/28/16

Rationale:

- -There remains a need for 2 schools that represent a combined 160K Sq. Ft. of space.
- Can't do 2 schools at once too expensive.
- -Deferring one school project for 5 7 years allows for decreased upfront costs and additional time to monitor student enrollment.
- -The established LBH structure is too large and not conducive for town use at any foreseeable time in the future.
- -The property of LBH cannot be sold.
- -The Flanders property is not a conducive sale site due to location.
- -The NCS property provides options:
 - Sell Property
 - Lease Space
 - · Repurpose the space for town use



Rationale Continued:

- -We are supporting the largest number of children first (combined LBH and NCS).
- -LBH is the least expensive stand alone option (to obtain 101K Sq. Ft. of space). In combination with the existing Flanders we meet the required 160 Sq. Ft. of needed space for all students.
- -Maintain 43% reimbursement with the LBH project.
- -Renovating our largest space allows for future options (adjusted size) with a new Flanders School.
- We maintain the same project construction timeline.
- -Previous LBH renovations (windows) can be retained.
- Potential to use the operating cost savings of NCS to help with the overall budget and new initiatives.

Questions, Comments and Discussion

MOTION: Eric Bauman moved to approve the total conceptual cost estimate of \$45,060,609 to renovate as new Lillie B. Haynes School and adding refurbishment funds for Flanders School not to exceed \$1.5 million dollars; advancing the project to the Board of Selectmen for their review and action as presented; Barbara Senges seconded.

Discussion ensued regarding equity among schools, transitioning options, follow through with Flanders construction in 5 to 7 years, and working collaboratively to make an amazing transition. Some Board members noted that by doing nothing, the district will patch buildings and may lose all opportunity for state reimbursement, and that the option presented is the best option to get through the BOS and BOF to move forward for a town referendum vote.

- Lawry O'Connell (81 East Pattagansett Road, East Lyme) thanked the Board for moving ahead with an elementary school building plan and hopes it will get through the town and pass referendum.
- Linda Johansen (East Lyme Teachers Association President) congratulated the Board on taking action regarding the elementary school building project. She stated that "Schools are the people in the schools that make things work, and we are all about your kids as we move forward."
- 3. Jen Murray (7 Tabernacle Avenue, Niantic) stated that she is looking for equity around the district and is disappointed the brakes were not put on the project tonight. He/She said the plan is not acceptable and too little playground space.

To the Board of Education:

I was discharged from the hospital today, and as I am now recovering, I am unable to attend tonight's meeting. I respectfully request that my questions below be read into the public record in lieu of my appearance before the Board.

I am a resident and taxpayer of East Lyme. My son is a graduate of East Lyme High School and my daughter is a pupil at Niantic Center School.

I request you consider and address the following questions as you prepare to take action on your plans for the district.

- 1. What is the reason for the apparent and sudden accelerated pace of your planning? It took six years to arrive at this point, but now there seems to be a rush with a whole new approach. Will you present evidence to the town of your due diligence?
- 2. Who has ultimate responsibility for deciding how to dispose of school properties—the Board of Education or the Board of Finance? This is unclear.
- 3. How many additional classrooms will need to be constructed at Lillie B. Haynes to support our students at their current class sizes?
- 4. Do you plan to house children at Lillie B. Haynes in portable classrooms during construction? If portables are used, instead of NCS remaining open during construction, what provisions will be made for these children to travel between them in inclement weather multiple times a day? What security measures will be in place?
- 5. Given the increase in enrollment at Lillie B. Haynes, what impact does this have on support services such as art, technology, PE, and cafeteria? How will those classrooms, the gymnasium, and cafeteria handle twice the number of students?

- 6. What environmental studies have been done on hazardous materials at LBH? We would like to see a printed copy of that report and how those hazardous materials are going to be mitigated. If there is figiable asbestos we want to know the plans for containing it and the plans to ensure the students in the building won't be exposed.
- 7. How do you plan to properly vet all construction workers and delivery persons? Will they all undergo background checks and fingerprinting?
