A. <u>Discussion/action re: Proposed Adoption of ELPS Budget for FY 2017-</u> 2018

Public Hearing preceded this meeting. Superintendent Newton stated the that the administration has done its very best to deliver a solid budget that is fiscally responsible. The Board acknowledged the district's work and thanked everyone for working so closely together.

Some Board comments included the following:

- Use of Security personnel (in lieu of the present greeters) at the Middle School and at the Elementary Schools did not address the use of security personnel for before and after school activities/functions. Only the regular school hours (including student arrival and dismissal) were addressed in the budget.
- The Board acknowledged the hard work and effort of the Administration in putting together this budget.
- The Board acknowledged the extra efforts put forth by Amy Drowne (Assistant Superintendent) to accomplish savings on the reading programs.
- We spent a little on technology in this budget but more on dues and sports.
