# A. Finance/Facilities/Community

### 1. Discussion/Action re: Proposed Graduation Date for ELHS Class of 2017

- Superintendent Newton recommended the ELHS graduation date be set for Friday, June 16, 2017 and the ELPS 2016-2017 School Calendar be adjusted to reflect Friday, June 16, 2017 as the last day of school for all ELPS students provided there are no additional school cancellations.
- This decision would provide for 180 school days for high school students and 181 school days for elementary and middle school students.
- Any additional school cancellation days that result in less the 180 school days required by CT law will be made up following the graduation date.
- The last day for teachers and paraprofessionals (teaching assistants and instructional aides) will be Monday, June 19, 2017.

Following discussion regarding the reasons for shortening the calendar to less than 182 school days, the Board supported the Superintendent's recommendation and added the school calendar as a future agenda topic.

**MOTION:** Al Littlefield moved to set the graduation date for the ELHS Class of 2017 as Friday, June 16, 2017 and to adjust the 2016-2017 ELPS Calendar to reflect Friday, June 16, 2017 as the last day of school for all ELPS students; providing 180 school days for high school students and 181 school days for elementary and middle school students. Any additional school cancellation days that result in less than 180 school days will be made up following the graduation date; Candice Carlson seconded.

# 2. <u>Discussion/Action re: Advertising Options for the East Lyme Athletic Complex</u>

- As requested by the Policy Review Committee, the Board continued review and discussion regarding EL BOE Policy and Regulation 1325, Community Relations – Advertising and Promotion and Commercial Activities and Policy 1360 – Naming School and Facilities and advertising options for the East Lyme Athletic Complex.
- Chair Tim Hagen posed the question that if the Board is approached by entities to entertain offers and bids for advertising, is this something the Board should seriously consider?
- If not, he encouraged the Board to discontinue further discussion on the matter.
   Several members spoke on the importance of taking a proactive approach to create revenue.
- Further discussion ensued and concerns were voiced regarding the responsibility of and lack of funding plans for the turf field replacement project (approximately \$400,000 in 10 years) and advertising criteria and guidelines (i.e., placement of advertising logos), legal issues.
- Board members unanimously agreed they were not interested in renaming facilities.

Chair Tim Hagen and Superintendent Newton will research the history of the turf field agreement, have a dialogue with the Board of Finance, seek legal advice on how best to advance this, and place the topic on the next BOE agenda.

# 3. <u>Discussion re: Alteration Project Update for the Three East Lyme Elementary</u> Schools

- Chair Tim Hagen announced the alteration project for all three elementary schools is moving forward thanks to a successful Town Referendum on March 28, 2017.
- The Design Steering Committee will meet on Thursday, April 6, 4:00 p.m. at Central Office to discuss next steps.
