#### 4. Shipman & Goodwin Suggested Education Stability Procedures for Transportation

#### 5. BOE Policy 4218.51 Personnel Social Media

- The Policy Committee reviewed the current BOE policy and suggested replacing it with Shipman and Goodwin's suggested policy.
- The Board of Education discussed:
  - a. Providing a social media refresher training for staff.
  - b. Should specific verbiage around alumni and social media with current staff and students be included?
  - c. Suggested that crowd funding be allowed only with prior permission from administration. The district needs to assess future costs associated with item or program crowd funded, who it belongs to, and educational equity among other classrooms.
  - d. Professional online accounts, not personal online accounts, should be used to forward posts, opinions, or advertisements.
